Dear Mr. Richardson:

On February 13, 2015, the U.S. Department of Education's (Department's) Federal Student Aid notified Wards Corner Beauty Academy (WCBA) of its intent to fine WCBA a total of \$15,000 for WCBA's failure to comply with the requirements of the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (the Clery Act) in Section 485(f) of the HEA, 20 U.S.C. § 1092(f), and the Department's regulations in 34 C.F.R. §§ 668.41 and 668.46. Specifically, WCBA failed to include three required policy statements in its calendar year 2010 ASR. The letter stated that the fine would be imposed on March 9, 2015 unless WCBA submitted a request for a hearing or written material indicating why the fine should not be imposed. As of the date of this letter, WCBA has not submitted a request for a hearing or written material.

Since WCBA has not appealed the proposed fine, the Department is imposing the proposed total fine of \$15,000 for the violation of the Clery Act described in our letter of February 13, 2015.

The \$15,000 fine is due to the Department within 30 days of the date of this letter. Payment must be in the form of a certified or cashier's check, and made payable to the U.S. Department of Education. If payment is not received by the Department within that 30-day time period, interest will accrue in monthly increments until payment is received.
